Subject: REMINDER - SBIRT Web Training

As a reminder, Providers and clinical staff may access the **FREE** online training for the **Screening, Brief Intervention & Referral for Treatment (SBIRT)** to assist Primary Care Physicians (PCPs) with Members whose alcohol and substance use may be negatively impacting their health and quality of life. The SBIRT online training is accessible through the IEHP Provider Portal by following these steps:

1. After logging into the Provider Portal, click on the SBIRT tab located on the left hand column. The SBIRT page will display a clickable link which will open a new page to the SBIRT online training.

2. To start the training, Providers will be prompted to create an account.

3. On the payment screen, Providers will be required to enter **coupon code: IEHP** in order to avoid being charged the \$50 program registration fee. Thus, no credit card information is needed.
