Subject: **Transgender Healthcare Providers**

The transgender population of the Inland Empire has been estimated at over 27,000 individuals, encompassing a very unique set of physical and mental healthcare needs and barriers.¹ Inland Empire Health Plan (IEHP) has been working on developing and maintaining a strong community network of physical and mental healthcare supports designed to care for the bodies and minds of transgender people.

Attached to this letter is a list of currently identified trans-competent and experienced healthcare Providers. Please feel free to utilize this list when working with transgender and gender nonbinary IEHP Members.

Included in the list are Primary Care Physicians (PCPs) who through the survey referenced below and interaction with IEHP have been identified as trans-competent and experienced in treating transgender Members. We included these PCPs as a reference for our Provider community so that those Providers who are less experienced in providing transgender health care services may refer their Members, if they deem appropriate, to the PCPs listed to request assignment to these PCPs' IEHP panels.

IEHP is also asking for assistance in identifying more Providers with experience and competency in providing transgender health and mental healthcare services to add to our growing community of IEHP transgender competent and experienced Providers.
